Materials covered by this warranty, supplied and installed by Olde World Cabinetry, or under its direction and supervision shall be guaranteed for a period of one (1) year from the date of substantial completion against defects in workmanship and material. (Substantial Completion is defined as installation of upper and lower cabinetry so as to have a functional area ready for countertop installation. Additional trim work or decorative accents may not be complete at this time or upper cabinetry which may not be installed until countertop installation).

Installation performed by Olde World Cabinetry, persons in its direct employ, or subcontractors employed specifically by it, is warranted to be of good and workmanlike quality in accordance with customary industry practices.

Warranty work will only be performed once the entire contract amount, including all extras and change orders, has been received by Olde World Cabinetry. Purchaser agrees that payment in full of the contract amount, together with all extras and change orders, is a condition precedent to Olde World Cabinetry's obligation to perform any warranty work.

ALL ARTICLES SUPPLIED BY OLDE WORLD CABINETRY BUT MANUFACTURED BY OTHERS SHALL NOT BE COVERED BY THIS WARRANTY OTHER THAN TO THE EXTENT OF THE WARRANTY GIVEN BY SUCH MANUFACTURER OR DISTRIBUTOR FROM WHOM THE FIRM OBTAINED THE PRODUCT, TO THE EXTENT SUCH WARRANTY IS ASSIGNABLE. CUSTOMER MUST FOLLOW THE WARRANTY POLICIES GIVEN BY SUCH MANUFACTURER OR DISTRIBUTOR FOR WARRANTY CLAIMS AND SERVICE.

In the event of defects in workmanship and material and the failure of products supplied by Olde World Cabinetry to conform to this agreement or warranty, Olde World Cabinetry will, at its election, repair, replace or make appropriate adjustment where an inspection discloses any such defects occurring in normal usage within one (1) year after installation provided that the defect or malfunction was not due to accidents, alterations to the goods or materials, misuse, abuse or neglect, or normal wear and tear. Cabinet door and drawer alignments/adjustments are not covered under warranty after original substantial installation. Olde World Cabinetry shall not be responsible for shipment and installation costs as the result of repairing or replacing the item.

In order to obtain performance of any warranty obligation from Olde World Cabinetry, the customer shall immediately contact Olde World Cabinetry in writing and cooperate fully in supplying the necessary information, as well as access to the premises, relative to the defect or malfunction.

The item purchased under this and the original agreement shall be used exclusively by the original customer and by no other person, and therefore there shall be no third party beneficiary to any of the warranties, express or implied, contained in this agreement. *Please note that warranty is not honored on any accounts with unpaid balances.*

OTHER THAN AS STATED HEREIN, ANY EXPRESS OR IMPLIED WARRANTIES, INCLUDING THOSE OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE EXPRESSLY DISCLAIMED. OLDE WORLD CABINETRY DISCLAIMS ANY LIABILITY FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES.
